Market consultations successfully finalised

Continuously operating in perilous situations, firefighters need a solution to monitor, measure, interpret and act on the environment. The solution must combine safety and comfort, in all situations. The reduction of injuries & casualties among firefighters is the main focus of the Smart@Fire project.

The Pre-commercial Procurement Tender

Based upon the results of the market consultations, the procurers (IBZ, IWT and SDIS13) have decided on the scope of the intended procurement and developed the detailed tender documents describing the functional requirements and other relevant specifications that the prototypes need to meet. Now the public tender has been launched.

IWT – the Agency of Innovation of the region of Flanders (Belgium) acts as Lead Procurer acting in the name and on behalf of a buyers group consisting in addition to IWT, of the Federal Ministry of Interior Affairs of Belgium (IBZ) and the Fire Department of the Bouches du Rhône region of France (SDIS13). Next to this, the fire brigade of Manchester, Dortmund and the Dutch IFV are partners in this project. They as well will look into the possibility of procuring the developed prototypes.

The Smart@Fire Pre-commercial Procurement will use a phased approach consisting of:


- Phase 1: solution design intended to demonstrate feasibility
- **OPHASE 2**: prototyping for the actual development and evaluation of the prototypes or demonstrators
- Phase 3: testing for the development and testing of a limited volume of first products/services (test series)

This PCP is financed by the European Commission and the three lead procurers: IBZ, IWT & SDIS13.

Only tenderers that have successfully bid and delivered for the preceding procurement phase will be able to bid for the subsequent phase.

THE DEADLINE FOR THE SUBMISSION OF TENDERS FOR PHASE ONE WILL END ON 13/10/2014 AT 12AM.
